NBBA W-W ELITE "TEAM" FUTURITY GUIDELINES

\$3000.00 Entry Fee

The 3rd Annual Bonanza Breeder's Invitational W-W Elite Team Futurity will be for Two year old bulls, born between January 1, 2010 till December 31, 2010. Team Entry Fees will be in the amount of \$3000.00 postmarked no later than January 30, 2012. All Bulls entered in the W-W ELITE Team Futurity must be ABBI registered or DNA verified through the NBBA.

The 2012 NBBA W-W "Team" Futurity Guidelines are as follows:

- 1 The Futurity will consist of 30 Team Entries on a first come first serve basis. To reserve a slot you must contact Bar F Productions, Inc. and entry must be postmarked by January 30, 2012. **Slots are not guaranteed until the money has been received.**
- 2 The Futurity will be held as a "Team" Futurity, a "Team" will consist of three (3) bulls. A contractor may mix bulls with other contractors, but all three (3) bulls on the team **MUST** pen together.
- 3 All owners must be current 2012 NBBA members in good standing. If a bull is owned and entered as a partnership, the partnership must have a current NBBA membership or all partners must have an individual NBBA membership.
- 4 All entries must be ABBI registered or DNA verified through the NBBA.
- 5 A photo static copy of the registration papers for the bull to be entered must be received on or before **January 30, 2011**. (If papers are not available, please send registration # on Futurity Entry Form and forward papers as soon as they are available.)
- 6 There will be **NO REFUNDS** given on Entry Fees, in the event a bull is ineligible to compete for any reason, the owner must replace the bull by the date specified. **NO EXCEPTIONS!!**
- 7 Alternate bulls and delivery changes will be accepted until Friday, February 3, 2012. **NO ALTERNATES OR DELIVERY CHANGES WILL BE ACCEPTED AFTER THIS DATE!!**
- ✧ **All Futurity bulls must have 180 days current Brucellosis and 180 days current TB Test and 30 days current Health Papers. NO EXCEPTIONS TO THIS!! REGARDLESS OF CURRENT STATE'S HEALTH REQUIREMENTS THIS IS MANDATORY FOR ALL BULLS!! IF THE BULLS DO NOT HAVE THE PROPER HEALTH REQUIREMENTS THEY WILL NOT UNLOAD AND WILL FORFEIT ALL ENTRY FEES!!**
- ✧ ****VIP NOTE:**
ALL COMPETITION BULLS ENTERING THE STATE OF TEXAS MUST HAVE A PERMIT # ON YOUR HEALTH CERTIFICATE DUE TO NEW TRICH REQUIREMENTS!!! THEY ARE NOT REQUIRED TO HAVE THE TRICH TEST BUT MUST HAVE A PERMIT #. IF YOUR BULL DOES NOT HAVE A PERMIT AND YOU ARE FROM A STATE OTHER THAN TEXAS, YOUR BULL WILL NOT BE UNLOADED PER TEXAS ANIMAL HEALTH STATE REQUIREMENTS!!!! ALL BULLS RESIDING IN TEXAS MUST HAVE THE APPROPRIATE TRICH STATEMENT REQUIRED BY TEXAS ANIMAL HEALTH, "BULLS ARE FOR EXHIBITION ONLY, NOT FOR SALE"!!
- 8 All bulls will be bucked under a dummy for 6 seconds, one round. (NBBA will provide Dummies and personnel to mount dummies).
- 9 Judging will consist of 6 Judges that will mark the bulls on their performance. The High and Low marks will be eliminated.
- 10 All "teams" will place on the average of their three (3) bulls combined scores.
- 11 NBBA Season Points will be awarded on the bulls individual placing in the event.
- 12 All bulls on a contractors "team" will draw together and will buck in that order.

- 13 All owners must flank their own bulls or have someone designated to flank their bull, **EVENT PERSONNEL WILL NOT FLANK BULLS**. Event personnel will mount all dummies.
 - 14 All bulls that place and a reasonable number of alternate bulls, will be mouthed by attending Event Veterinarian, unless the bull has previously been mouthed and cleared by the NBBA. Any bull mouthed over age will be disqualified and all money, prizes and entry fees will be forfeited. **The Event Veterinarian's ruling is FINAL and there is NO APPEALS PROCESS!!**
 - 15 All bulls must be housed in pens provided by event management and must be checked in by 2:00 P.M. on Friday, February 10, 2012, **NO EXCEPTIONS!! THERE WILL BE A \$100.00 FINE TO ANYONE WHO IS NOT CHECKED IN BY 2:00 P.M.!**
 - 16 **All FUTURITY bulls entered must have their horns tipped to the size of a QUARTER. Any FUTURITY bull arriving without their horns tipped to the size of a QUARTER, the bull WILL BE disqualified and forfeit all entry fees and the owner will be subject to a fine of up to \$250. NO BULLS WILL BE TIPPED AT THE EVENT!!**
 - 17 All bulls entered must have a permanent fire or freeze brand identification number which matches the identification number on registration papers. Any owner who's bull arrives without permanent identification number matching identification number on registration papers or will be denied entry, will forfeit all entry fees and will be subject to a fine determined by event management **The NBBA has the authority to pull DNA on the bull.**
 - 18 **The NBBA prohibits** the use of anabolic steroids, drug masking agents, diuretics and specifically reserves the right to test, or to allow the event management to test, any bull at any time using accepted scientific methods in the industry. **Testing expense may result in a minimum lab fee of \$30 deducted per entry.** Any entrant of a bull testing positive for anabolic steroids, drug masking agents, diuretics may be subject to sanctions including forfeiture of any prize money and accumulated points, expulsion from the NBBA, **a minimum fine amount of \$5000** and any other sanctions deemed appropriate at the discretion of the NBBA Board of Directors. Any animal testing negative but repeatedly showing high testosterone levels may be subject to additional testing at the discretion of the NBBA Board of Directors.
- **The NBBA defines the following as prohibited "anabolic steroids": Boldenone Undecylenate (Equipoise®); Stanozolol (Winstrol®); Clenbuterol (Clenbuterol Hydrochloride); Ventipulmin and any form of Testosterone.**
- 19 The NBBA will not tolerate or allow owners to inject any medication to any bull at an NBBA Sanctioned event. In the event a bull needs medical attention, the veterinarian on staff will administer the injections from his or her inventory. Any owner found giving an injection to any bull will face a minimum fine amount of \$250.00 and disqualification of the bull at that event.
 - 20 This event is an NBBA sanctioned event and will be governed by the NBBA Rules

****Bonanza Breeder's Invitational Individual Bull Challenge****

A contractor may pay an additional entry fee in the amount of \$500.00 per bull to enter any of the bulls on his "team" in an additional purse. The bulls **MUST be entered in the "Team" W-W Futurity to compete in the Individual Bull Challenge.

I understand that the NBBA prohibits the use of anabolic steroids, drug masking agents, diuretics and has the right to test any bull at any time using accepted scientific methods in the industry. In the event my bull is tested and tests positive for anabolic steroids, drug masking agents, diuretics, I agree the NBBA exclusively owns all rights to any and all test results and that NBBA Standing Rules will be enforced.
