## 2012 NBBA EAST TEXAS BONANZA HEIFER TEAM FUTURITY \$1000.00 Entry Fee Per Team

The East Texas Bonanza Heifer Team Futurity will be for Yearling heifers, born between January 1, 2011 till December 31, 2011. Team Entry Fees will be in the amount of \$1000.00 postmarked no later than March 12, 2012. All heifers entered in the Team Futurity must be registered prior to entry.

### The 2012 Heifer "Team" Futurity Guidelines are as follows:

- 1 The Heifer Futurity will be held as a "Team" Futurity, a "Team" will consist of three (3) heifers. A contractor may mix heifers with other contractors, but all three (3) heifers on the team **MUST** pen together.
- 2 All entries must be registered prior to entry.
- 3 There will be **NO REFUNDS** given on Entry Fees, in the event a heifer is ineligible to compete for any reason, the owner must replace the heifer by the date specified. **NO EXCEPTIONS!!**
- 4 Alternate heifers and delivery changes will be accepted until Friday, March 16, 2012. **NO ALTERNATES OR DELIVERY CHANGES WILL BE ACCEPTED AFTER THIS DATE!!**
- ★ All heifers must have a 365 day current negative TB & Brucellosis test and a 30 day current health paper. **NO EXCEPTIONS TO THIS!! REGARDLESS OF CURRENT STATE'S HEALTH REQUIREMENTS THIS IS MANDATORY FOR ALL BULLS!! IF THE BULLS DO NOT HAVE THE PROPER HEALTH REQUIREMENTS THEY WILL NOT UNLOAD AND WILL FORFEIT ALL ENTRY FEES!!**
- 5 All heifers will be bucked under a dummy for 5 seconds, one round. (CF Productions will provide Dummies and personnel to mount dummies).
- 6 Judging will consist of 6 Judges that will mark the bulls on their performance. The High and Low marks will be eliminated.
- 7 All "teams" will place on the average of their three (3) heifers combined scores.
- 8 All bulls on a contractor's "team" will draw together and will buck in that order.
- 9 All owners must flank their own heifers or have someone designated to flank their heifer, **EVENT PERSONNEL WILL NOT FLANK HEIFERS.** Event personnel will mount all dummies.
- 10 All heifers must be housed in pens provided by event management and must be checked in by 2:00 P.M. on Friday, March 23, 2012, **NO EXCEPTIONS!! THERE WILL BE A \$100.00 FINE TO ANYONE WHO IS NOT CHECKED IN BY 2:00 P.M.!**
- 11 **All FUTURITY heifers entered must have their horns tipped. Any FUTURITY heifer arriving without their horns tipped, the heifer WILL BE disqualified and forfeit all entry fees and the owner will be subject to a fine of up to \$250. NO HEIFERS WILL BE TIPPED AT THE EVENT!!**
- 12 All heifers entered must have a permanent fire or freeze brand identification number which matches the identification number on registration papers. Any owner who's heifer arrives without permanent identification number matching identification number on registration papers or will be denied entry, will forfeit all entry fees and will be subject to a fine determined by event management **The NBBA has the authority to pull DNA on the bull.**
